1. OBJECTIVE & SCHEDULE

Global Vantage Law & Society Exchange Workshop 2022 ("GV Exchange Workshop") aims to enhance our awareness of multifaceted contemporary issues in law and society by exchanging diverse perspectives between the students across borders and cultures. Since the most serious disruption of global education caused by COVID-19, it has been more important than ever to stay connected and learn from each other. With the expected mutual benefits of sharing and collaboration in learning, we openly encourage the members of our partner universities to make the best use of this international forum to get together for a dialogue where we, as responsible and sensible global citizens, think about and tackle the problems we are currently facing. In this workshop, we discuss a number of key human right issues through the case of Japan.

The GV Exchange Workshop consists of 3 official events $(1 \sim 3)$ over 2 weeks.

- 1. **Day 1** (**February 5**th, **2022**) offers (i) special lectures on *human rights in Japan* and 5 main topics to be discussed for academic activities, which will be followed by (ii) group discussion for each pre-assigned group.
- 2. **Day 2 (February 12th, 2022)** invites (i) 2 groups of the same topic to make group presentations and discussion about their respective themes under the same topic category; and (ii) all the participating universities to introduce cultural activities or performances followed by a conversation session in group.
- 3. Day 3 (February 19th, 2022) calls on (i) 5 groups of different topics to make their presentations and discuss each group's theme; and (ii) every participant to engage in a feedback session.

2. PARTNER UNIVERSITIES TO BE INVITED

- 4-5 partner universities in the Asian region (due to time difference), including:
 - o Ateneo de Manila University, Philippines
 - National Taiwan University, Taiwan
 - o Pusan National University, Republic of Korea
 - o University of Malaya, Malaysia

3. GROUP FORMATION & WORK

- 10 participants from each participating university are invited to join the workshop.
- Each participant will be assigned to each group from *Group* 1 to *Group* 10.
- 2 groups will be assigned to 1 of the 5 Main Topics. (See 4(1))
- Each participating university is responsible for the task of group assignment.

4. ACADEMIC ACTIVITIES

- (1) 5 Main Topics (the numbers of assigned groups)
 - Freedom of Expression and the Press (Group 1 Group 2)
 - <u>Hate Speech</u> (*Group 3 Group 4*)
 - Gender Equality (Group 5 Group 6)
 - **Poverty** (*Group* 7 *Group* 8)
 - Refugees & Migrants (Group 9 Group 10)

(2) Special Lectures (Lecturers)

- Professor Sanae Fujita, University of Essex
- Professor Mariko Igimi, Kyushu University

(3) Discussion

- Preparation for a group presentation and discussion: weekdays on the 1st week and 2nd week
- <u>Day 1</u>: one-group discussion, <u>Day 2</u>: two-group (topic-based) discussion, <u>Day 3</u>: five-group (large group) discussion

5. CULTURAL ACTIVITIES

Each university is expected to introduce and share its culture – video or/and oral presentation about **traditional foods** & **trendy foods** – which will be followed by breakout sessions for further exchange & conversation for better understanding about each other's culture.
