East Asian Law Series 2016-Civil Law

## Course Introduction



In recent decades, East Asia countries have experienced dynamic changes in terms of economics, structure of societies, and law. Thus, National Taiwan University College of Law will launch East Asia Law Series in Summer Program 2016 to provide a comprehensive concept in civil law, criminal law, corporate law of Asian countries in comparative perspective. The series begins with the introduction of Asia Civil Law. Four international renowned scholars will lead prospective students through the path. Professor Okino Masami (沖野 真己) from University of Tokyo and Professor Lei Chen (陳磊) from City University of Hong Kong will give lectures depicting civil law in Japan and China while Dean of NTU Law Professor Sheng-Lin Jan (詹 森林) and Professor Ying-Chieh Wu (吳英傑) from NTU will introduce civil law in Taiwan and Korea. Together, we expect a complete picture of civil law in Asian countries will be presented.



## Lecturers

### Professor OKINO Masami



Prof. Okino Masami completed her LL.B. at University of Tokyo and her LL.M. at University of Virginia. She joined University of Tokyo as a faculty member since 2010. She is the author of "Consumer Contracts and Alternative Dispute Resolution in Japan" (Journal of the Japan-Netherlands Institute) and "Regulating Contract Formation" (The Journal of Private Law). She is also the co-author of Bankruptcy Law (co-authored with Prof. Kazuhiko Yamamoto, Tadashi Nakanishi, Masatoshi Kasai and Hironori Mizumoto) and contributed to the book *Trustee's Duty Loyalty as a Default Rule, in Future of Civil Law, Formation of Contracts*.

### Professor Lei CHEN



Lei CHEN is an associate professor with tenure at City University of Hong Kong Law School. He has published extensively in the areas of property theory, contract law, and Chinese legal history. His writings on these subjects appear in international referred law journals, edited volumes of multidisciplinary scholarship, and legal monographs. He has been conducting empirical legal research on Chinese Property law and contract law with three GRF grants from the Hong Kong Research Grant Committee. He sits on the editorial boards of peer-reviewed journals and book series. He is also associate director of the Center for Chinese and Comparative Law. Prof. Chen is an associate member of the International Academy of Comparative Law and a Fellow of the European Law Institute.

### Professor Sheng-Lin JAN



Professor Jan received his Doctor of Laws at the Johann Wolfgang Goethe University in Frankfurt, Germany and earned the degree of Dr. iur. in February 1992. Prof. Jan has been a faculty member at the NTU College of Law since 1992. He specializes in civil law, consumer protection law, government procurement law and comparative private law, and has prolifically written articles on issues of these topics. He was the founding Director of the Graduate Institute of Interdisciplinary Studies. He mainly teaches Civil Code-General Principles, Civil Code-Law of Obligations, Consumer Protection Law, Chinese Civil Law, Case Studies on Contract Law and Tort Law, Case Studies on the Development of the Supreme Court Decisions, and Comparative Study on German Court Decisions.

### Professor Ying-Chieh Wu



Professor Wu studied at Brasenose College, Oxford and acquired DPhil in law in 2011. He is an assistant professor at NTU College of Law and teaches civil law (obligation and property). Before joining NTU in 2013, he conducted his doctoral research on comparative trusts law at the University of Oxford, and was previously a law lecturer and research professor at Korea University, School of Law. Prof. Wu's main research areas are obligation, property, trusts and comparative private law, especially in the comparison of civilian and common law property/trust laws. Thus, his articles mostly dealt with comparative trusts/property law (i.e., 'Constructive Trusts: A Civilian Approach', 'Unlocking three requirements of Real Subrogation' etc.). Recently Prof. Wu contributed to the book *Trust Law in Asian Civil Law Jurisdictions: A Comparative Analysis*.
